- Overall scores will be calculated based on the number of correct responses out of a total of 60 marks.

- The SLAT PI, or the Personal Interview within the SLAT framework, is a crucial phase aiming to assess candidates beyond academic prowess, focusing on their aptitude and personal attributes relevant to pursuing a legal education.
- It carries substantial importance, accounting for 30% of the total evaluation, emphasizing the significance of a candidate's performance and presentation during this interview in determining their admission prospects.
